### GENERAL RULES AND REGULATIONS FOR ELECTRIC SERVICE DEFINITIONS

### **SECTION 2**

The following terms when used in these General Rules and Regulations, in rate schedules and in service arrangements, unless otherwise stated in an approved rate schedule or executed service agreement, will have the meanings stated below:

**2.01 BILLING PERIOD:** An interval of approximately 30 days, unless otherwise specified or appearing from the context to cover a different period. [199--20.3(6)]

**2.02 BUILDING:** A single structure which is unified in its entirety, both physically and in operation. Separate structures on the same tract of land, or separate structures on adjoining tracts of land (even though separated by public or private way), may be considered as a building if such separate structures are physically joined by an enclosed and unobstructed passageway at or above ground level and both are occupied and used by the customer for one single business enterprise.

**2.03 CLASSIFICATION OF CUSTOMERS:** Customers are grouped into specific categories having broad similarities. The categories or classes generally relate to the quantity of energy used on a monthly basis. [199--20.2(4)]

**2.03A RESIDENTIAL USAGE CUSTOMER:** An individual consumer using electric service for general household purposes in space occupied as living quarters, such as single private residences, single flats, apartment units, or single mobile homes. Customers with 50% or more of their usage for these purposes are considered Residential Usage customers.

**2.03B NON-RESIDENTIAL GENERAL SERVICE USAGE CUSTOMER:** A customer using electric service in the conduct of an enterprise or activity in space occupied and operated for commercial, institutional or industrial purposes.

**2.03C LARGE GENERAL SERVICE USAGE CUSTOMER:** A large customer using electric service in the conduct of an enterprise or activity in space occupied and operated for commercial, institutional or industrial purposes.

2.04 BOARD: The Iowa Utilities Board. [199--20.1(3)]

**2.05 COMPANY:** Interstate Power and Light Company

**2.06 COMPLAINT:** "Complaint" as used in these rules is a statement or question by anyone, whether a customer of the Company or not, alleging a wrong, grievance, injury, dissatisfaction, illegal action or procedure, dangerous condition or action, or Company obligation. [199--20.1(3)]

### GENERAL RULES AND REGULATIONS FOR ELECTRIC SERVICE DEFINITIONS

**2.07 CUSTOMER:** Any person, firm, association, or corporation, any agency of the federal, state, or local government, or legal entity which has timely completed application for service and is responsible by law for payment for the electric service from the Company. [199--20.1(3)]

**2.08 CUSTOMER'S INSTALLATION:** All wiring, appliances and apparatus of every kind and nature on Customer's premises on Customer's side of the point of delivery (except Company's meter installation) used or useful by Customer in connection with the receipt and utilization of electric service.

**2.09 DELINQUENT OR DELINQUENCY:** Means an account for which a service bill or service payment agreement has not been paid in full on or before the last day for timely payment. [199--20.1(3)]

**2.10 DISTRIBUTION LINE:** The physical facilities of Company required to provide service to Customer, including the lines (exclusive of service wires, meter poles and metering installation), transformers, substations, and other requisite facilities.

**2.11 ELECTRIC SERVICE:** The maintenance by Company at the point of delivery, of a source of electric supply at approximately the standard voltage and frequency consistent with the class of service rendered, as stated or implied in the service agreement, irrespective of whether or not Customer makes use of such service.

**2.12 INTERCONNECTION COSTS:** Qualifying facilities and AEP facilities shall be obligated to pay interconnection costs, as described in Iowa Administrative Code (IAC) 199 – Chapter 45.

**2.13 LINE EXTENSION:** Any addition to the electric distribution system (exclusive of service wires) to provide electric service to a Customer.

**2.14 METER INSTALLATION:** The meter or meters together with auxiliary devices, if any, constituting the complete installation needed by Company to measure the class of electric service supplied to a Customer at a single point of delivery.

**2.15 NOTICE, GIVING OF:** Except as otherwise specified, when notice is required to be given to Customer, it will be deemed sufficient if delivered to Customer or Customer's agent in charge of the premises served, or if mailed postage paid to Customer's last known address, as shown by the records of the Company. When notice is required to be given to Company, it will be in writing, delivered or mailed postage paid, addressed to Company at any of its offices.

### GENERAL RULES AND REGULATIONS FOR ELECTRIC SERVICE DEFINITIONS

**2.16 POINT OF DELIVERY:** The point at which Company's conductors and electrical facilities (other than Company's meter installation) first make electrical connection with Customer's installation unless otherwise specified in the service agreement. The energy supplied by Company becomes the property of Customer at the point of delivery.

**2.17 PREMISES:** That separately-walled portion of a single building, undivided by any common area, or that separate portion occupied by Customers of a single, contiguous tract of land (including all improvements thereon) undivided by any public way. All common areas in any such building or on any such tract of land occupied by the owner or the lessee of such building or tract of land or his authorized agent may be deemed by Company to be another Customer. A common area shall include all halls, lobbies, passageways and other areas of a building or a tract of land used or usable by persons other than Customer.

**2.18 SERVICE AGREEMENT:** The application, agreement or contract, express or implied, pursuant to which Company supplies electric service to a customer.

**2.19 SERVICE TERRITORY:** Territory in which Company has the right to supply or make electric service available.

**2.20 SERVICE LINES:** Those wires or cables extending from Company's electric distribution system to the point of delivery.

2.21 SERVICE LINES EXTENSION: Any addition to Company's service wires.

**2.22 TARIFF:** A published volume of rate schedules and general rules and regulations on file with the lowa Utilities Board under which electric service is offered and taken.
