- E. Dairy variable speed drive vacuum pumps: Must be controlled by UL-listed device that meets applicable IEEE standards for harmonic control. Must be for blower-style pumps. Rotary-vane vacuum pumps not eligible. Existing vacuum pump must not have existing VFD.
- F. Dairy heat reclaimer: Qualifying units include Century-Therm, FreHeater, Heat Bank, Sunset, Superheater and Therma-Stor. Must have an electric water heater. Existing system does not have heat reclaimer installed.
